No Greater Sacrifice (NGS) grants are awarded to children of fallen and wounded Service members with the goal of providing a debt-free undergraduate college education. NGS delivers scholarships and resources to improve their quality of life through the pursuit of higher education. NGS honors the sacrifices of our Service members by investing in their children's capacity for greatness through education. In addition to the critical funding, NGS provides personalized mentorship to each scholar and their families to help them better define their career and educational

goals, and to improve their quality of life through the pursuit of higher education.

The scholarship covers tuition and fees (up to the cost of Public In-State University/College Tuition and Fees), room and board, books, and special equipment.

To monitor the use of grant funds, through the application process a scholar's eligibility is verified based on Department of Defense and Veteran's Affairs related documentation to ensure the NGS requirements are met for selection. A funding liability is established based on information known at time of selection.

For each school term, each scholar's detailed request for funds are reviewed by both the Executive Director and NGS Board Member and Military Family Liaison with approval from the NGS Finance Committee (composed of: Chairman, Treasurer, Director of Investments) prior to disbursing funds.

Funds are disbursed directly to the college or university, when possible, to be applied to the student's account/expenses with NGS being the last dollar to ensure their account is fully paid. Along with NGS, the funds are monitored with the schools and scholars with any unused funds returned to the organization. Additionally, each scholar is reviewed by the board annually.

Any remaining liability at the time of completion is then able to be used for new scholars.

In 2020, NGS awarded \$913,500 in scholarships to 25 new scholars, and increased \$20,009 in scholarships to 4 current NGS scholars for a total of \$933,509 in Scholarship expense.

The net present value is based on the scholar's age and discount rate, and is adjusted annually to reflect changes in various factors, most notably the scholar's age. The COVID-19 outbreak in the United States and around the world has caused business disruption due to mandatory lockdowns implemented in most states in order to slow down the spread of the virus. NGS' management monitored the situation and implemented certain changes in its operations and events in order to mitigate the impact of this pandemic. One change included a decision to not host in-person fundraising events. Also, the population NGS serves was impacted in many ways, including colleges and universities closing their on-campus learning and living. Due to the continued uncertainty in both fundraising and need, NGS was conservative to ensure all commitments and additional 2020 commitments would be secure. Management expects to commit and fund more scholarships in the near future which should return grant expenses to a more typical level for the organization. While the disruption is currently expected to be temporary, there is considerable uncertainty around its duration, and the full financial impact cannot be reasonably estimated at this time.

In accordance with GAAP accounting, the net present value of the 2020 scholarships awarded must be determined. The net present value is based on the scholar's age and discount rate, and is adjusted annually to reflect changes in various factors, most notably the scholar's age.

Typically the previous year's funding determines the number of new scholarship commitments. However due to Covid-19 and its impact, the amount for new commitments at the time of selection was altered. NGS is
